ORDER

Sanction is hereby accorded to release of Rs.50,000/- (Rupees fifty thousand only) in favour of Sh Fayaz Ahmad Sofi S/o Ab Satar Sofi R/o Dhobipora District Ganderbal bearing registration No. JK0115009085 dated 15.05.2021 for mitigating the expenditure on account of Professional Degree Course of his Daughter namely Minha Fayaz who was persuing B.E in C.E, 2<sup>nd</sup> semester Session 2021-2022 at SSM College of Engineering and Technology.

The Assistant Labour Commissioner Ganderbal shall release the payment on the following terms and conditions, that:-

- I. The beneficiary is actual Building and Other Construction Worker as defined under Section 2-(e) of the Act.
- II. The payment is made to the rightful claimant.
- III. The ALC concerned shall re-verify the case and satisfy himself that the case is genuine before making payment
- IV. Before making the payment, the ALC shall complete all the requisite Codal formalities and will maintain the proper record and ensure that the beneficiary has not availed the said assistance in the current year
- V. The payment shall be released in favour of the registered construction worker if the concerned Institute/ college refuses to accept the cheque. The payment shall only be released in favour of the construction worker subject to the production of NOC from the concerned college/institute
- VI. The payment shall be made strictly in accordance with the Rules and guidelines issued by the J&K BOCWWB from time to time.
- VII. Before making the payment, every entry in the passbook shall be completed and arrears on account of Monthly Contribution shall also be received under Rules
- VIII. U.C/Red Account shall be submitted by ALC at the end of every month without waiting for the call from this Office
- IX. The Instructions (Alert Note 83/2021) issued vide this office letter No. CEO/J&K/BCB/2021/1711-37 dated 06.10.2021 should be followed in letter & spirit
