Sub: Minutes of the meeting of J&K Building and Other Construction Workers Welfare Board held on 11-04-2012 at 11 AM in committee Room Civil Ist Floor Civil Secretariat, Jammu under the Chairmanship of Hon'ble Minister for Higher Education, Labour & Employment J&K.

At the outset, Commissioner/Secretary Labour and Employment welcomed the Chairman and the members. The meeting started with reviewing the implementation of the Welfare Schemes for the construction workers. Chief Executive Officer/Secretary of the Board putforth the detail figures before the Board with regard to collection of Cess, registration of Construction workers and detail of benefits/beneficiaries; The Board noted the progress made in a short period with satisfaction.

Thereafter agenda items were taken for deliberations and following decisions were taken.

1. **Confirmation of the minutes of meeting held on 13-02-2012:-**

Minutes of the meeting held on 13-2-2012 issued by Chief Executive Officer/Secretary J&K Building and Other Construction Workers Welfare Board vide No. CEO/J&K/BCB/012/3823-60 dated: 21-02-2012 were approved by the Board. However word “**unanimously**” used in para 2.1 under the heading “vesting of power to Assistant Labour Commissioners regarding sanctioning and disbursement of financial assistance shall be deemed as deleted abinitio.

2. **Ex-gratia relief in favour of the dependents of Sh. Saif Din S/o Gaffar Shah R/o Pumote Shryan Tehsil Doda District Doda un-registered Construction Worker:-**

Ex-gratia relief in favour Sh. Saif Din S/o Gaffar Shah R/o Pumote Shryan Tehsil Doda District Doda un-registered construction was approved subject to the fulfilment of all the formalities before sanctioning the case, provided it is established that the deceased un-registered construction worker was eligible for registration on the date of application made by him.

3. **Creation of staff at Central/Provincial/District Level:** It was decided that a Sub-Committee consisting the following members of the Board will look into the necessity/financial implications for the staff purposed to be created at various levels (State, Provincial & District) of the Board.

- (i) Principal Secretary to Government Finance Department or his representative.
- (ii) Commissioner Secretary Law, Justice and Parliamentary Affairs or his representative.
- (iii) Commissioner Secretary Labour and Employment .
- (iv) Labour Commissioner .
- (v) Chief Executive Officer/Secretary J&K Building and Other Construction Workers Welfare Board.
- (vi) Any other person as may be required by the Chairman of the Sub-Committee.

The report of the Committee shall be placed before the Board in the next meeting for further action.

4. **Housing Loan Scheme for Registered Construction Worker:-**

The sub-committee constituted as mentioned at Para 03 above will also submit a report for consideration of the Board with regard to feasibility/guidelines for implementation of scheme.

5. **Information with regard to authorization of Budget provisions for 2012-13:-**

The Budgetary provisions for 2012-13 approved and conveyed vide administrative Labour and Employment Department vide letter No. L&E/Plan/BOCW-88/2011 dated: 03-04-2012 was noted by the Board with satisfaction.

6. **Framing of rules:**

It was decided that process for framing the rules for the Board shall be completed within one month after having the same vetted by the expert committee as required under section 5 of the Building and Other Construction Workers (RE&CS) Act 1996.

7. **Printing of Stationery i.e. I-Cards, Forms and Registers:**

It was decided that Chief Executive Officer/Secretary of the Board shall get the stationery i.e. I-Cards, Registers, Receipts, etc printed from private Press on competitive rates by floating tender or inviting quotations. **Hon'ble Chairman stressed for making the I-Cards more inclusive and attractive.**

At the end the Hon'ble Chairman desired for publication of half yearly **NEW LETTER** of the Board with regard to the detail of the registration and benefits provided to the registration construction worker.

The meeting ended with vote of thanks to the chair.
