In this connection it is to inform you that all the information sought by you is available on our website "www.jkbocwwb.org". However for your convenience, I am hereby sending the following documents which contains all the information sought by you.

1. Booklet containing all information regarding schemes, including procedure etc 37 leaves.
2. SRO 373 having all the legal procedures for payment on account of schemes regarding implementation of the Building and Other Construction Workers (RE&CS) Act 1996 in the State of Jammu and Kashmir 10 leaves.

So far as the information sought for detail of name etc is concerned that can be taken from Assistant Labour Commissioner Poonch after depositing the fee provided under Rule. As we have shortage of staff and there is huge rush of the beneficiaries, so you are requested to give me the priorities for the record you want to inspect, so that Assistant Labour Commissioner could be directed accordingly. It is pertinent to mention that as per the provisions of the Building and Other Construction Workers (RE&CS) Act 1996 and Rules made there under, we are taking all possible efforts to make the system foolproof. Your concern within regard to mushrooming of agent system is a serious problem, which we are facing throughout the State. We are working on the project for making the whole system of registration and payments through e-governance. You are also requested to go through the documents provided by me and discuss the suggestions you have for making the system more transparent. If you have prepared any list of wrong registration or payments same may be provided to me for initiating recovery process. Bring some substantial proof of role in payments against any agent we will take legal action. Your suggestions and cooperation which would be in the interest of the poor will always be appreciated.
